



LOCKING DEVICE INSTALLATION INSTRUCTIONS



WARNING – USE OF LOCKING DEVICES



Do not store keys

in lock.

- Always keep your firearm pointed in a safe direction, including when you are installing or removing your locking device.
- Always verify that your firearm is completely unloaded before installing your locking
- Do <u>not</u> install locking devices in the trigger guard; always keep your fingers and locking device outside the trigger guard during device installation and removal.
- · Store firearms, ammunition and keys separately and securely, away from children and careless adults; do not store your firearm with the keys in the locking device.
- · Do not attempt to work the action of your firearm with the locking device in place; this may damage your firearm.
- While locking devices are an important aid to security measures, they are not a substitute for safe firearm handling and proper storage. Remember that any mechanical device can be bypassed with enough time, knowledge, determination and equipment.

LOCKING DEVICES MUST BE **USED SAFELY AND** RESPONSIBLY


It is important to use the locking device on your Ruger[®] firearm when the firearm is stored or immediate use is not planned.

Keep the muzzle pointed in a safe direction and your fingers outside the trigger guard at all times!

To Install the Factory-Supplied Locking Device:

1. Remove the magazine from your pistol. Be sure the firearm and its magazine are completely unloaded and contain no cartridges or cartridge cases!

- 2. Open the action completely. When the bolt is all the way back, push up on the bolt release to keep the action open.
- 3. Insert the cable directly into your pistol as shown in Figure 2.
- 4. To lock: With the key turned to the farthest clockwise position, insert the loose end of the cable into the lock. Turn the key counterclockwise and remove it from the lock.
- 5. Once the lock is securely closed, pull firmly on the lock to test the connection and be sure it is locked. Do not leave or store your firearm with the key in the lock! Store your locked unloaded firearm and the key in secure, separate locations, away from ammunition, children, and unauthorized adults.

GENERAL INFORMATION AND MECHANICAL CHARACTERISTICS

The **RUGER® LC CHARGER™** is an internal hammer-fired, magazine-fed, autoloading, blowback operated, centerfire pistol. The **RUGER®** LC **CHARGER™** features a Secure Action™ fire-control mechanism similar to the RUGER-5.7™, LCP® II, and SECURITY-9® pistols. Ruger's safe, reliable and proven Secure ActionTM fire-control mechanism combines a protected internal hammer with a bladed safety trigger. The hammer and sear are designed to engage with significant mechanical overlap. This requires additional cocking of the hammer during trigger pull and keeps the hammer and sear securely engaged under the full force of the hammer spring. Additionally, a neutrally balanced sear and strong sear spring ensure continuous, positive engagement of the hammer. The trigger has a short, smooth pull, clean break, and positive reset. Despite longer cartridges, the steel magazines and high strength glass fiber nylon grip frame provide a slim comfortable grip not much larger than most 9mm double-stack pistols. The textured grip frame provides a secure gripping surface in all conditions. The **RUGER® LC CHARGER™** features ambidextrous manual safety levers and an extended magazine release. The handguard and receiver are precision CNC machined aluminum with an integral Picatinny rail. The handguard also features M-LOK® slots for installation of popular accessories. Visit magpul.com/instructions for information on how to properly install and use M-LOK® accessories. The **RUGER® LC CHARGER**[™] also features a reversible, non-reciprocating charging handle.

The **RUGER® LC CHARGER™** utilizes a blowback design in which the barrel and two-piece bolt are held together by the recoil spring at the moment of firing. Depressing the trigger safety allows the trigger to fully travel rearward. The trigger bar transfers this movement to the sear, which rotates in contact with the hammer, compressing the hammer spring until the sear disengages and the hammer falls against the firing pin, igniting the primer. The recoiling bolt

As the bolt travels rearward, the rear bolt and attached extractor pull the spent cartridge case from the chamber and cock the internal hammer. As the bullet moves down the barrel and exits, the two-piece bolt moves rearward until impacting the buffer pad. After the bolt reaches full rearward travel, the compressed recoil spring begins to push the bolt forward. The rear bolt picks up the top cartridge from the magazine, pushing it into the chamber. Releasing the trigger allows the trigger bar to move back into position, resetting the pistol to its ready-to-fire condition.

The user of this or any autoloading pistol must always remember that when fired, it automatically reloads and re-cocks itself, so that simply pulling the trigger will fire the pistol again. Removing the magazine does not prevent the pistol from firing. The firearm can be fired with the magazine removed if there is a round in the chamber. Therefore, an autoloading pistol user must be particularly conscious to always keep the pistol pointed in a safe direction.



WARNING – PISTOL MAY FIRE WITH MAGAZINE REMOVED

The pistol will fire if there is a cartridge in the chamber and the trigger is pulled, whether or not there is a magazine in place! Removing the magazine does not unload the pistol. Never assume the pistol is unloaded. Visually inspect the chamber and the magazine each time the pistol is handled to be certain there are no cartridges in either.



WARNING-HAND STOP USAGE



The LC Charger™ comes equipped with a hand stop mounted on the lower portion of the handguard. The hand stop helps ensure that you always keep your support hand behind the muzzle.

DO NOT ATTEMPT TO GRASP THE HAND STOP AS A GRIP WITH YOUR SUPPORT HAND, AND ALWAYS MAKE SURE THAT YOUR SUPPORT HAND REMAINS BEHIND THE MUZZLE.

DO NOT REMOVE THE HANDSTOP!

KEEP HANDS AWAY FROM MUZZLE

The **RUGER® LC CHARGER™**, as equipped from the factory, is not regulated by the National Firearms Act ("NFA"). However, alterations to the pistol (including the addition of a stock assembly, vertical foregrip, or "pistol brace") may reclassify the pistol as an NFA-regulated firearm. For more information about the NFA, please visit ATF.gov.



WARNING – NATIONAL FIREARMS ACT

The National Firearms Act, 26 U.S.C. Chapter 53, prohibits the unauthorized making, manufacture, and possession of certain firearms, including:

- 1) A rifle having a barrel of less than 16 inches in length;
- A weapon made from a rifle if such weapon as modified has an overall length of less than 26 inches or a barrel of less than 16 inches in length;
 and
- 3) A handgun with a secondary vertical fore-grip installed.

Unauthorized possession, making, or manufacture of any NFA-regulated firearm is a felony under the NFA and may also be illegal under state or local law.

All users should familiarize themselves with and comply with all federal, state, and local laws and regulations regarding the possession and use of firearms.

OPERATION OF MANUAL SAFETY

The **RUGER® LC CHARGER™** is equipped with ambidextrous external manual safety levers. The safety should be in its "safe" position at all times except as necessary for the operation and maintenance of the pistol.

The ambidextrous manual safety may be engaged or disengaged from either the left or right side lever. To engage the safety, move either the right- or left-hand safety lever fully upward to the "safe" position. The safety levers will point to the "S" on either side. If the safety levers are pointing elsewhere, the safety is not in the "safe" position. Do not attempt to engage the safety while pulling the trigger.

The safety mechanism locks the trigger bar which locks the trigger. The trigger cannot be pulled with the safety on.

To disengage the manual safety, <u>point the pistol in a safe direction</u> and push either safety lever fully downward. Both safety levers pointing to the "F" on either side of the grip frame signifies that the safety is disengaged and the pistol is ready to fire.

See Figures 3 and 4, below, which illustrate the two positions of the safety.

WARNING - MANUAL SAFETY



Placing the safety in an intermediate position between "safe" and "fire" can result in the user thinking the pistol is in a safe or fire position when it is not. Pulling the trigger with the safety in an intermediate position may cause the pistol to fire. Therefore, always move the safety fully to its intended position and then check to be sure it is where you want it to be.

Keep the safety "ON" unless actually firing. Always move the safety fully to its intended position and check it. The safety is not "ON" unless it is completely "ON." Never depend on a safety mechanism or any other mechanical device to justify careless handling or permitting the pistol to point in an unsafe direction. The only "safe" pistol is one in which the bolt is open, the chamber is empty, and there is no magazine in the firearm.


KNOW HOW TO USE THE SAFETY

Additional safety features include: integrated trigger safety to block the trigger unless it is intentionally pulled; neutrally balanced sear with significant engagement and strong spring tension; and hammer catch to help prevent the hammer from contacting the firing pin unless the trigger is pulled.

OPERATION OF BOIT RELEASE

When the last shot has been fired and the magazine is empty, the bolt release automatically holds the bolt open. Likewise, fully retracting the bolt manually when there is an empty magazine in the pistol will also hold the bolt open. To lock the bolt to the rear when there is a loaded magazine inserted in the pistol, or no magazine in the pistol, first point the pistol in a safe direction then fully retract the bolt using the charging handle with the non-firing hand while pushing up on the bottom of the bolt release with the firing hand (see Figure 5a). If a round was chambered, it should extract and eject as you retract the bolt manually. Once the bolt is locked back, visually inspect the chamber to ensure it is empty. The non-reciprocating charging handle can be returned to the forward position.

To release the bolt, remove the empty magazine and simply pull the bolt back using the charging handle with the non-firing hand and let it go. Alternately, you can depress the bolt release with your finger (see Figure 5b). If a loaded magazine is inserted, pulling the bolt back with the charging handle and letting it go (or depressing the bolt release), will chamber a round. Keep your fingers away from the trigger and ejection port, and keep the muzzle pointed in a safe direction.





WARNING – JARRING PISTOL CAN RELEASE BOLT AND CHAMBER A ROUND

The bolt release is NOT a safety device. It should not be used to hold the bolt back when there are cartridges in the magazine. A slight jar to the butt end of the pistol CAN cause the bolt release to disengage and feed a cartridge into the chamber. The bolt release should only be relied upon to hold the bolt in its rearward position when the chamber is empty and an empty magazine is in place. The bolt release is there for convenience when changing magazines and to hold the bolt in its rearward position when the pistol is unloaded for cleaning or inspection.

OPERATION OF MAGAZINE RELEASE

When a magazine is fully inserted into the magazine well, it is automatically held in place by the spring-loaded magazine latch. The magazine release is the button or lever to the rear of the trigger guard. *Different configurations may be included or available as Genuine Ruger factory accessories on ShopRuger.com.*When depressed, the magazine release will permit removal of the magazine from the pistol. Under normal conditions, the magazine will fall free of the pistol when the magazine release is depressed. To avoid damage and debris entering the magazine, do not let it fall to the ground. In the event the magazine becomes stuck in the magazine well, it can be manually extracted by pressing the magazine release while pulling on the magazine base pad (see Figure 6).



WARNING: Removing the magazine does not prevent the pistol from firing. The pistol can be fired with the magazine removed if there is a cartridge in the chamber. Therefore, an autoloading pistol user must be particularly conscious to always keep the pistol pointed in a safe direction and keep fingers out of the trigger guard and away from the trigger when not firing.


REVERSIBLE CHARGING HANDLE

The charging handle of the **RUGER® LC CHARGER** $^{\mathsf{m}}$ can be configured for either left- or right-handed operation.

The handguard must be removed to reverse the charging handle. See Handguard Removal instructions on p. 35.

1. **CAUTION:** Wear eye protection. Insert a non-marring tool into the hole of the cover plate (see Figure 7a) and slide the cover plate forward until it is no more than 2/3 free of the receiver (see Figure 7b).

WARNING: There is a spring-loaded pin under heavy tension which will be released when the hole in the cover plate reaches it.







2. Cup one hand over the hole in the cover plate and use the other hand to pull the cover plate forward. (See Figure 8.) The spring-loaded pin will pop out and should be captured by hand.



3. Tilt the pistol over and allow the contents of the small hole that is now exposed to fall free. These include a pin, a safety spring, and a safety detent plunger (see Figure 9). If stuck, they can be gently pushed out from the opposite side with a small punch or hex wrench. Set these aside in a secure place for reuse. Slide the cover plate all the way off.



4. Reach through the receiver from the reverse side where the charging handle is located with a 1/8" hex wrench and unscrew the charging handle bolt. (See Figure 10.) **NOTE:** If extra leverage is needed, a socket screwdriver or pliers may be used on the leg of the hex wrench. Set the charging handle aside and carefully remove the charging handle bolt through the slot with the hex wrench by leaving the hex wrench in the bolt and tilting the pistol over on the opposite side.



5. Flip the pistol over. Insert the non-marring tool through the hole in the side plate and pull it forward for removal. (See Figure 11.)



6. Using a small flathead screwdriver, remove the charging detent stop by turning it counterclockwise. (See Figure 12.)



7. Flip the pistol over. Using a small flathead screwdriver, install the charging detent stop by turning it clockwise (see Figure 13). Torque the detent stop to 10-15 in-lb.




8. Insert the slide plate into the slot of the receiver. (See Figure 14.)



9. Place the charging handle over the hole in the side plate (see Figure 15a). While holding the charging handle in place, insert the charging handle bolt through the opposite side of the receiver (see Figure 15b). Tighten the bolt to 20-25 in-lb.






10. Slide the cover plate through the slots on left-side of the receiver so the hole in the cover plate lines up with the hole in the receiver. (See Figure 16.)


NOTE: Be sure to insert the cover plate with the beveled flat edge facing up as shown in Figure 9, p. 17.

Insert the detent plunger, spring, and pin in the hole as demonstrated in Figure 16.



11. Using a punch or 1/8" hex wrench, press down on the pin in the hole of the cover plate. **WARNING:** The spring-loaded pin is under heavy tension.

As you compress the pin, slide the cover plate over the hole and all the way to the rear. (See Figures 17a & 17b.)





AMMUNITION

Be certain to use the correct cartridge for your firearm, and do not attempt to load any other cartridges into the magazine or chamber of the pistol other than what is specified.

The **RUGER® LC CHARGER™** is compatible with newly loaded factory ammunition conforming to C.I.P. standard dimensions and pressures for 5.7x28mm ammunition. No "+P" or "+P+" ammunition should ever be used in this firearm.

No reloaded ammunition should ever be used in this firearm. The use of non-conforming, reloaded, or specialty ammunition may reduce reliability or cause damage or injury.


MAGAZINES

The magazine follower must move freely and have adequate tension so that each cartridge is quickly raised to the feeding position. The magazine feed lips should be clean and free of cracks so that cartridges are held in their proper feeding position. If damage is present, the magazine should be replaced. **NOTE:** The rear "dents" on each side of the feed lips help retain the rim of the cartridge and are normal. (See Figure 18a.)

To load the magazine, press cartridges straight down through the feed lips, one at a time, until the magazine is full.

Ensure the top cartridge is fully seated against the rear of the magazine. (See Figure 18b.)

To unload the magazine, slide each cartridge forward and out of magazine, one at a time, until the magazine is empty.






If the magazine becomes dirty, it should be disassembled and thoroughly cleaned. Be sure the magazine is unloaded before disassembly. Use a punch to press in on the magazine spring seat where it protrudes into the hole in the magazine floorplate (see Figure 19). Slide the magazine floorplate toward the front of the magazine. **CAUTION**: The magazine spring is under heavy spring tension. Be careful to prevent the forcible ejection of the magazine spring seat and compressed magazine spring by retaining them with your hand while removing the floorplate (see Figure 20). Withdraw the magazine spring seat, magazine spring, and magazine follower from the magazine body.





Reassemble the magazine in the reverse order, making sure that the spring and follower are oriented as shown in Figure 21.

Insert the magazine spring with the magazine spring seat parallel to the base of the magazine body.



DAMAGED, NON-STANDARD OR IMPROPERLY ASSEMBLED MAGAZINES SHOULD NOT BE USED. THEY CAN CAUSE THE PISTOL TO MALFUNCTION.

Clean all magazine components with a brush or rag to remove residue. You may use a suitable solvent that will not rust the metal components or adversely affect the magazine body. After cleaning, remove all excess solvent from the magazine components. A few drops of light oil applied to a lint free cloth and wiped on the magazine body and spring will help prevent rust. It is not necessary to lubricate the magazine.

WARNING: Penetrating oils and solvents inside a magazine can "kill" or weaken cartridge primers or powder which can result in failures to fire or other possibly dangerous malfunctions, such as leaving a bullet in the bore!

After cleaning and reassembling the magazine, always check to be certain that the magazine follower moves freely and forcefully to the top of the magazine and that no solvent or debris remain. Improper reassembly of the magazine can cause malfunctions.

SIGHTS

Some models of the **RUGER® LC CHARGER™** may not come equipped with factory sights. Do not operate the pistol without first attaching an appropriate sighting device. The full-length Picatinny rail may be used to attach front and rear iron sights, including a variety of AR-type "flip" sights, or may be used for optical sights. A red dot or "reflex" type sight is considered ideal for this type of pistol, however, a long eye-relief pistol scope may also be used. Follow the manufacturer's instructions for mounting and adjusting accessory sights. Recommended options are available on **ShopRuger.com**.

DRY FIRING

Going through the actions of cocking, aiming and pulling the trigger on an <u>unloaded</u> firearm is known as "dry firing." It can be useful to learn the "feel" of your firearm. Be certain that the firearm is fully unloaded (both the chamber and magazine are empty) and that it is pointing in a safe direction when you are practicing dry firing. The **RUGER**® **LC CHARGER**™ can be dry fired without damaging the firing pin or other components.

The firearm should never be dry fired while disassembled. This could result in damaging the ejector.


NOTE: When dry firing the **RUGER® LC CHARGER™**, the trigger mechanism will not reset unless the bolt is retracted approximately 1".

TO LOAD AND FIRE (WITH MAGAZINE)

Before you attempt to load and fire the pistol, first read through this manual completely and be certain you understand the pistol's operation.


Before each firing session, visually inspect the firearm and its magazine to ensure no components are damaged, missing, loose, bent, cracked, chipped, or peened. Ensure the firearm is free of dirt, dust, sand, lint, or environmental debris. The firearm should be cleaned and lightly lubricated in accordance with the instructions (see p. 45). You should also perform a function check (see page 44) on the unloaded firearm to ensure it operates properly and that all safety devices are in proper working order.

- Be certain the muzzle is pointed in a safe direction and the safety lever is in the upward "safe" position. Keep your finger off the trigger until you are ready to immediately shoot at a target! Ensure your target lies in a safe direction with adequate backstop beyond it. (See "The Basic Rules of Safe Firearms Handling," p. 59.)
- 2. Pull the charging handle fully to the rear until the bolt stops and lock it open by pushing upward on the bolt release (see Figure 22).



- 3. Insert a loaded magazine into the grip frame, taking care that the magazine is locked in place by the magazine latch. Inserting the magazine forcibly is not necessary.
- 4. Hold the pistol firmly in the shooting hand with your fingers away from the trigger. Keep the pistol pointed in a safe direction. With the other hand, grasp the charging handle and pull the bolt to the rear as far as it will go. When released, the bolt will fly forward to strip the top cartridge from the magazine and chamber it.

The firearm is now loaded. If the firearm is not to be fired immediately, the safety should remain in the "safe" position.



- 5. Keeping your pistol pointed downrange, take aim at your target using your sights. Move the safety lever to the downward "fire" position. The first shot can be fired by pulling the trigger all the way to the rear. Subsequent shots are fired one at a time by repeated pulling of the trigger until the magazine is empty.
- 6. At any time, if the pistol is not being fired, keep it pointed in a safe direction (downrange) and place the safety lever in the upward "safe" position.
- 7. When the last cartridge in the magazine has been fired, the empty magazine will activate the bolt release and hold the bolt open. If the bolt is shut, the shooter should always assume that there is a cartridge in the chamber!
- DO NOT rely on your memory or the word of others to know if a firearm or magazine is loaded. With the pistol pointed in a safe direction, visually inspect the magazine and chamber.

NOTE on Chamber Checks: Hold the pistol at an angle where you can clearly see the chamber in the rear of the barrel. If you cannot clearly see the chamber with the bolt fully retracted, you can manually control the bolt and ease it forward slightly to get a better view of the chamber. Then, fully retract the bolt once more to lock it open with the bolt release.



TO RELOAD THE PISTOL

- Firing all cartridges in the magazine and the chamber will cause the bolt to automatically lock open. Keep the pistol pointed in a safe direction. Engage the safety by moving the safety lever upward so that the levers are pointing to the "S" on either side of the receiver. Press down on the magazine release. The magazine will fall free of the pistol. To avoid damage and debris entering the magazine, do not let it fall to the ground.
- 2. Insert a loaded magazine. **WARNING:** When there is a loaded magazine in place and the pistol is jarred, the bolt can fly forward and chamber a cartridge. For this reason and as an essential safety practice, the pistol should always be pointed in a safe direction with fingers away from the trigger.
- 3. Release the bolt by pulling the charging handle fully to the rear and releasing it or by depressing the bolt release. A cartridge will be chambered when the bolt shuts. NOTE: DO NOT attempt to control the charging handle while chambering a round. This may result in the round not chambering properly.
 - The firearm is now loaded. If the firearm is not to be fired immediately, the safety should remain in the "safe" position.
- 4. When you are finished firing the pistol, unload it completely (see "To Unload" p. 27).

IF NECESSARY, TO LOAD AND FIRE (WITHOUT MAGAZINE)

The **LC CHARGER™** can be used in a single-shot mode in the absence of a magazine or for training purposes. To do so, place the firearm on safe, remove the magazine, and lock the bolt to the rear. With the firearm pointed in a safe direction, carefully place a single cartridge into the chamber. The chamber can be accessed through the ejection port. Retract the charging handle to its extreme rearward position and release it. This will cause the bolt to be released and move fully forward. The firearm is now loaded.

CAUTION: The bolt is under heavy spring tension and can injure fingers if it were to slam shut!

If the firearm is not to be fired immediately, the safety should remain in the "safe" position. Firing without a magazine, the bolt will not remain open after the single round is fired.



TO UNLOAD

(Firearm Must Be Kept Pointed In A Safe Direction)

UNLOAD THE FIREARM IMMEDIATELY WHEN YOU ARE FINISHED SHOOTING!


NOTE: This sequence must be followed exactly. Failure to do so can result in the firearm's chamber becoming unintentionally loaded with a cartridge!

- 1. Keep the muzzle pointed in a safe direction at all times and keep fingers outside the trigger guard. Move the safety to the "safe" position.
- 2. Remove the magazine. If an empty magazine is in the firearm when a cartridge is extracted from the chamber, it may be ejected into the magazine area instead of outside the firearm. **Remember** that even though the magazine has been removed, a cartridge remaining in the chamber can still be fired!
- 3. Using the charging handle, vigorously retract the bolt to its open position to extract the chambered cartridge and hold it in place by pressing the bolt release up (see p. 14).

Always visually double check the chamber to be certain it is empty. Hold the
pistol at an angle where you can clearly see the chamber in the rear of the
barrel.

NOTE on **Chamber Checks:** Hold the pistol at an angle where you can clearly see the chamber in the rear of the barrel. If you cannot clearly see the chamber with the bolt fully retracted, you can manually control the bolt and ease it forward slightly to get a better view of the chamber. Then, fully retract the bolt once more to lock it open with the bolt release.

- 5. The only "safe" firearm is one in which the bolt is open, the chamber is empty, and there is no magazine in the firearm.
- 6. At this point, you may insert the cable lock for storage.
- 7. Cartridges can be removed from the magazine by sliding each cartridge forward and out of the magazine, one at a time, until the magazine is empty. Do not use a loaded cartridge or other items as a 'tool' to strip cartridges from the magazine.





WARNING-BORE OBSTRUCTIONS



Before loading or shooting your **LC CHARGER**TM, be certain the bore is unobstructed. Firing the pistol with any obstruction in the bore may result in severe damage to the pistol and serious injury to the shooter and other persons nearby.

A MISFIRE or unusual report (sound) upon firing is always a signal to cease firing immediately. After waiting for one minute, remove the magazine, lock the bolt open, and ensure that the chamber is empty. It is not sufficient to only examine the chamber in these instances. You must be certain the bore is free from obstructions. In some firearms, it will not be possible to easily make a determination by simply looking. In such cases, you should use a rod to confirm the bore is free of obstructions. Failure to detect and correctly remove a bore obstruction can result in serious injury to the shooter and bystanders, and damage to the firearms.

DO NOT "SHOOT OUT" A BORE OBSTRUCTION

TO CLEAR A MALFUNCTION ("JAM" or "MISFIRE")

Any autoloading firearm may occasionally malfunction. If it does:

- Be certain the muzzle is pointed in a safe direction and the safety is on "safe" at all times. Be certain bystanders are not close and that you are wearing eye and hearing protection and that your face is a safe distance from the firearm so that any discharge resulting from a jammed cartridge will not injure anyone.
- 2. If the misfire is the result of a cartridge not firing or unusual report (either louder or quieter than normal), keep the firearm pointed in a safe direction for one minute. Then, remove the magazine, retract the bolt to remove the cartridge from the chamber, and lock the bolt to the rear. Inspect the cartridge to determine if it had been fired or struck by the firing pin.
- 3. If you suspect a bullet or other obstruction may be lodged in the bore, first unload then, using a cleaning rod, inspect the bore for a bore obstruction. Bore obstructions must be removed using a properly sized cleaning rod and reasonable force. Failure to detect and correctly remove a bore obstruction can result in serious injury.

- 4. In the event of a fired or unfired cartridge is stuck in the ejection port area, (failure to feed or eject) first, if possible, remove the magazine.
 - Use extreme care if the magazine is held in place by a partially chambered cartridge.
 - b. Keep your face away from the ejection port during this operation.
 - c. Use only wooden 'tools' so that a cartridge will not be ignited if you strike a primer, and so that the chamber and magazine will not be damaged. A 3/16" wood dowel rod with a point on one end is useful.
- 5. In the event a fired or unfired cartridge is stuck in the chamber (failure to extract) first, if possible, remove the magazine and draw the bolt vigorously to the rear several times to bring the jammed cartridge along. If not, hold the bolt open with the bolt release and, using only wooden tools, attempt to free the cartridge. Never use a cleaning rod to push out an unfired cartridge.
- 6. Safely dispose of any cartridges involved in a malfunction incident. Do not use damaged ammunition in any firearm.
- If the malfunction cannot be corrected, contact a gunsmith or Ruger Customer Service.

TO MINIMIZE MALFUNCTIONS ("JAMS" or "MISFIRES")

Most malfunctions are caused by improper or damaged magazines, ammunition, or poor maintenance.

- 1. Clean and inspect the magazines according to the instructions on pp. 22 and 23.
- 2. Use only correct factory loaded ammunition. Try changing to another type or brand of ammunition of the proper caliber. When using any autoloading firearm, form the habit of examining fired cartridge cases. If they frequently show splits or bulges on any part of the case, cease using that type of ammunition and try a different type of the same caliber. If the problem persists, contact Ruger Customer Service.
- 3. Clean and lubricate the firearm according to the instructions on p. 45. Pay particular attention to the bolt, the extractor, the chamber, and the feed ramp. (See the "To Clean and Lubricate" section p. 45 for detailed cleaning instructions).
- 4. Remove excess oil and solvent from all cleaned components, load the magazine, and try the firearm again. As always, proceed slowly. Be certain bystanders are not close and that you are wearing eye and hearing protection and that your face is a safe distance from the firearm so that any discharge resulting from a jammed cartridge will not injure anyone.

If the above procedures do not result in a smooth and reliably functioning firearm, cease using the firearm and contact Ruger Customer Service. See the Service and Parts Policy section p. 50 of this manual.

A WARNING – MALFUNCTIONS



Any jam or feeding problem is a signal to immediately stop using the firearm until it can be determined what is wrong. Most failures of a cartridge to feed or to chamber are caused by a damaged magazine, improper firearm handling, or defective ammunition. Whatever the cause, cartridge jams can result in the potentially dangerous situation of a cartridge discharging before it is chambered. If this occurs, the cartridge case will rupture and its fragments will fly out of the firearm with sufficient force to cause injury. Always wear shooting glasses and hearing protectors! Keep face away from chamber!

STOP USING YOUR FIREARM IMMEDIATELY

DISASSEMBLY

Make Sure Firearm Is Unloaded!






NOTE: After ensuring your **LC CHARGER**[™] is unloaded (see pages 27 - 28), be sure the bolt is in the forward position before removing the grip frame. See "Operation of Bolt Release," p. 14.


Grip Frame Removal - (See Figures 23 - 25):

- 1. Using a punch or similar tool, push the takedown pin out of the receiver from either side. Be sure to retain the takedown pin.
- 2. With the muzzle pointed in a safe direction and keeping your fingers clear of the trigger guard, securely grasp the handguard and pull rearward on the grip.





Slide the grip frame assembly rearward, then down and off of the receiver assembly.



Bolt and Return Spring Removal - (See Figures 26 - 31):


 With the receiver assembly upside down, slide the two piece bolt all the way rearward with the charging handle so the rear bolt is past the breech of the barrel.

CAUTION: Hold the charging handle all the way to the rear to avoid pinching your fingers while removing the rear bolt. The bolt is under heavy spring tension while retracted.





- 2. Slide the rear bolt straight out of the main receiver cavity.
- 3. Slowly, with the charging handle, allow the front bolt to slide forward.






4. Tilt the buffer pad forward to get your finger behind it. While putting pressure towards the front of the pistol, pull the buffer pad up out of the firearm. The recoil spring and guide rod assembly will come with it.






5. Slide the front bolt back past the breech of the barrel and pull it out of the receiver cavity.




Handguard Removal - (See Figures 32 - 33b):

1. Using a 1/8" hex wrench, remove the three screws (shooter's right, left and bottom) from the rear of the handguard.



2. Slide the handguard forward and off the front of the receiver. Be careful not to allow the handguard to contact, scratch, or otherwise damage the barrel.






REASSEMBLY

Again, Be Sure Pistol is Unloaded!

Handguard Reassembly - (See Figures 34 & 35):

- 1. Slide the handguard onto the front of the receiver.
- Using a 1/8" hex wrench, install the bottom screw first. Next, install the screws on the shooter's right and left. Torque the screws to 40 in-lbs. DO NOT EXCEED THE SPECIFIED TORQUE. Doing so may seriously damage the receiver.






Bolt and Return Spring Assembly - (See Figures 36 - 42):

1. With the slot facing the rear of the receiver, slide the front bolt down into the rear receiver cavity.



2. Slide the front bolt forward until the keyway is roughly lined up with the breech of the barrel.




3. Insert the rounded tip of the guide rod and recoil spring assembly into the smaller hole in the rear of the front bolt.




4. Push the front bolt forward with the guide rod and recoil spring assembly.




5. Compressing the guide rod/recoil spring assembly slightly, push on the buffer pad until it can be inserted down into the receiver.



- 6. Move the front bolt all the way rearward with the charging handle and hold it in this position.
- 7. Lining up the tab on the front of the rear bolt and the slot on the front bolt, slide the rear bolt down into the receiver cavity.




8. With the charging handle, slowly allow the two-piece bolt to be driven forward by the guide rod/recoil spring assembly.




Grip Frame to Receiver Assembly - (See Figures 43a - 44b):

1. With the receiver and grip frame upside down, line up the four insert tabs of the grip frame with the tab clearances in the receiver.



2. Push the grip frame forward to lock the tabs into the receiver slots until the back of the grip frame is aligned with the rear of the receiver.



3. Insert the oval end of the takedown pin into the hole on either side of the receiver and push it through until both ends are flush with the receiver.





REVERSIBLE MAGAZINE RELEASE REPLACEMENT INSTRUCTIONS

Pistol Must Be Completely Unloaded Prior to Disassembly!

The magazine release lever on the **LC CHARGER**[™] can be replaced with the reversible magazine release button found on the **RUGER-5.7** Pistol.


Remove the grip frame from the receiver (see "Disassembly" section, "Grip Frame Removal," steps 1 - 3, pp. 32 - 33).

Remove Magazine Release Lever:

1. Rotate the magazine release lever as shown in Figure 45.




At the same time, push in on the flat side of the lever from the opposite side while also depressing the magazine latch from inside the grip frame (see Figures 46a & 46b).



As soon as you feel the flat side of the lever pop through the grip frame you will be able to pull the lever out.

CAUTION: Be careful as you pull the magazine release lever out of the grip frame as the magazine release spring may drop out of the lever (see Figure 47). If the spring does drop out, reinsert it as shown in Figure 48.


NOTE: Store these parts in a safe place for future use.





Install Magazine Release Button:

1. The magazine release button may be inserted on the left or right side of the grip frame. Use finger pressure to pop it into place while depressing the magazine latch inside the magazine well. (See Figures 49a & 49b.)



Reinstall Grip Frame to Receiver Assembly:

Refer to the "Reassembly" section, "Grip Frame to Receiver Assembly," steps 1 - 3, pages 39 - 40.


To Reinstall Original Magazine Release Lever:

NOTE: The original **LC CHARGER**[™] magazine release lever can be reinstalled into your firearm. However, the magazine release lever can only be installed on the left side of the grip frame.

Refer to the "Disassembly" section, "Grip Frame Removal," steps 1 - 3, pp. 32 - 33.

1. Use a non-marring tool, such as a wooden dowel, to press on the flush non-protruding side of the magazine relase button. The button will come free of the grip frame. (See Figures 50a & 50b.)





2. While depressing the magazine latch (see Figure 49a, p. 42), insert the magazine release lever into the left-side of the grip frame (see Figure 51) far enough so the magazine latch catches the notch in the lever.

CAUTION: Be sure the magazine release spring is positioned correctly in the magazine release latch before inserting it into the grip frame. (See Figure 48, p. 42.)



NOTE: Before pressing the magazine release lever all the way into the grip frame, depress the leg of the magazine release spring so it clears the grip frame as the lever is fully inserted. (See Figure 52.)



Check the function of the lever before reinstalling the grip frame to the receiver.

Reinstall Grip Frame to Receiver Assembly:

Refer to the "Reassembly" section, "Grip Frame to Receiver Assembly," steps 1 - 3, pages 39 - 40.

CHECK YOUR PISTOL'S FUNCTION

Periodic inspection of any firearm is important to ensuring its safe operation. It is important to clean and inspect your firearm after each range session or whenever the firearm has been exposed to sand, dust, moisture, humidity, or other adverse conditions. Proper maintenance increases the longevity of your firearm and will allow early detection of worn or broken parts.

Prior to each use, visually inspect the firearm to ensure no components are damaged, missing, loose, bent, cracked, chipped, or peened. If you observe excessive wear, you should stop using your pistol and contact customer service or a trained, certified gunsmith to evaluate its condition and replace any worn parts, if necessary.

After any disassembly and reassembly, it is important to verify that the action is working correctly before any live firing is attempted.

FIRST, BE SURE THERE IS NO AMMUNITION IN THE CHAMBER OR THE MAGAZINE AND KEEP THE PISTOL POINTED IN A SAFE DIRECTION!

a. <u>CHECK THE BOLT FUNCTION:</u> With the magazine removed, pull the bolt fully to the rear and release it. The bolt should operate smoothly and travel freely within the receiver without binding. Repeat this process two more times.

b. CHECK THE SAFETY FUNCTION:

First, using the charging handle, pull the bolt fully to the rear and release
it. This should cock the internal hammer.

- Continued on Next Page -

- Next, engage the safety by pushing it into the "safe" position and attempt to pull
 the trigger. With the safety in this position, the trigger should not move fully
 rearward and the hammer should not fall.
- Finally, move the safety to the "fire" position. Pull the trigger and listen for an audible "click" as an indication the hammer has fallen, striking the firing pin.

c. Check the bolt release function:

- With the bolt closed, insert an empty magazine and ensure it locks into place.
- Next, pull the charging handle fully rearward and ensure the bolt is automatically held to the rear by the bolt release.
- Push the charging handle forward to its closed position and ensure it is held in place.
- Press the magazine release and ensure the empty magazine drops free.
- Finally, retract the charging handle to its extreme rearward position and release
 it. This will cause the bolt release to drop and the bolt to be released and move
 forward.

If any of the above function checks fail or if you are uncertain, please consult a competent gunsmith or contact Ruger Customer Service at 336-949-5200 for further firearm inspection before using the pistol.

TO CLEAN AND LUBRICATE

BEFORE CLEANING, BE CERTAIN THE PISTOL AND ITS MAGAZINE ARE UNLOADED.

At regular intervals, or whenever the firearm has been exposed to sand, dust, extreme humidity, condensation, immersion in water, or other adverse conditions, disassemble, clean, and oil it. Proper periodic maintenance is essential to the reliable functioning of any firearm.


To clean the pistol, proceed as follows:


- 1. Disassemble (field-strip) the firearm to the extent described on pp. 32 36.
- 2. To clean the barrel, run a cleaning rod with a properly sized solvent-wetted patch through the bore several times. Then, attach a .22 caliber or .223 caliber copper brush to the cleaning rod and wet it with solvent. The rear of the barrel may be accessed through a port at the rear of the receiver. Run the brush forward through the full length of the barrel as many times as necessary to remove fouling from the bore. To clean the chamber, use a 7mm or .30 cal copper brush with solvent to scrub the chamber. After brushing, clean the bore with dry patches to remove the solvent and examine. Repeat until clean,then run a lightly oiled patch through the bore and chamber to lubricate. Finally, run one more dry patch through the bore and chamber to remove excess lubricants. Excess lubricants in the barrel and chamber attract and hold dust and can interfere with proper functioning.
- 3. Using plastic-safe firearms cleaning solvent and bristle brush, clean the bolt, receiver and fire control unit. After cleaning, wipe all surfaces clean with very lightly oiled cloth. Use of certain cleaning solvents, including those containing acetone, can damage the finish.

4. Lubrication. Apply a small amount of firearms lubricant to reduce friction on moving parts such as the bolt, recoil spring, and the area of contact between the hammer and hammer toggle (see Figure 53). Only a light application is needed to provide adequate lubrication of moving parts and to prevent rust. Excess accumulations of oil tend to attract particles of dust and dirt and may congeal in cold weather which can interfere with the safe and reliable functioning of the pistol.

IMPORTANT: The hammer toggle pocket must be lubricated in the area indicated (see Figure 53). A grease such as Mil-Comm TW25b is recommended. If the firearm is aggresively cleaned (such as an ultrasonic cleaner), then this grease must be replenished.

The front and rear bolt should each be lightly lubricated on their left and right sides. Use a high-quality gun oil with good long-term stability and lubricity, such as CLP. (See Figure 54.)







WARNING-LUBRICATION

Firing a firearm with oil, grease, or any other material even partially obstructing the bore or chamber may result in damage to the firearm and serious injury or death to the shooter and those nearby. Do not spray or apply lubricants directly on ammunition. If the powder of a cartridge is affected by the lubricant, it may not be ignited, but the primer firing may push the bullet into the bore where it may be lodged. Firing a subsequent bullet into the obstructed bore may damage the pistol and cause serious injury or death to the shooter and those nearby. Use lubricants properly. You are responsible for the proper care and maintenance of your firearms.

IMPROPER LUBRICATION DESTROYS FIREARMS

INSPECTION AND MAINTENANCE

Firearms are exposed to extreme heat and stress. The proper care of any firearm should always include periodic inspection for worn or broken parts to protect your investment and ensure a lifetime of safe shooting. A firearm with worn-out or broken parts may continue to function, however it will eventually fail or become unsafe to shoot. Clean and inspect your pistol after each range session and replace worn parts as needed.

Disassemble and clean your pistol in accordance with the instructions found in this instruction manual. Before lubricating, visually inspect the entire pistol for damaged or missing components. A scuffed or shiny appearance in high friction areas is normal. Cracks, burrs, and peening are indicators that parts need to be replaced to prevent further deterioration from occurring.

Common replacement parts may be purchased on ShopRuger.com. Additional GENUINE RUGER® FACTORY parts can also be ordered through Ruger Customer Service. After replacing any worn parts, lubricate, reassemble, and perform a function check as outlined in this instruction manual on the unloaded firearm to ensure it operates properly and verify that all safety devices are in proper working order.

If you have any questions or concerns about the safe operation of your firearm, contact Ruger Customer Service or your local trained and certified gunsmith.


Thread Protector and Muzzle Devices

Ensure that all muzzle devices installed on the **LC CHARGER**TM are intended for use on firearms chambered in the caliber marked on the receiver. Failure to do so may result in injury and damage to your pistol or device.

NOTE: Some **RUGER® LC CHARGERS** $^{\text{\tiny{M}}}$ are equipped with a non-threaded muzzle for consumers in those states which have feature-based restrictions.

Threaded muzzle **LC CHARGERS**™ chambered in 5.7x28mm come equipped with a ½"-28 threaded muzzle and corresponding thread protector.

The thread protector is retained in position by a factory-installed O-Ring when manually tightened (see Figure 55). If the factory-provided thread protector is replaced with a different muzzle device, the O-Ring must be removed. Removing the O-Ring ensures that muzzle devices tighten directly against the barrel shoulder, concentrically to the bore.



CAUTION: When using a suppressor for the first time, it is recommended to check for proper alignment of the suppressor to the bore. This can be achieved with an alignment rod or by fully disassembling the firearm, then looking through the barrel from the port at the rear of the receiver.

CAUTION: Suppressors may increase backpressure through the ejection port when firing. It is important that you ALWAYS wear eye protection when shooting.

CAUTION: "Hearing safe" for a single shot may still be damaging over longer durations of noise exposure. Most 5.7x28mm ammunition is supersonic. It also produces a high volume of gas. Suppressors that were specifically designed for other calibers may be less effective when used with 5.7x28mm ammunition. Hearing protection should always be worn.

WARNING: Periodically check tightness of muzzle devices when firing to prevent damage. Never install, uninstall, tighten, or adjust muzzle devices on a loaded firearm. Always unload completely and keep the muzzle pointed in a safe direction before working on any firearm. Use leather gloves to tighten a hot suppressor or allow it to cool. Suppressors may cause a shift in the point of impact requiring adjustment of the sights. Reliability will vary depending on the combination of ammunition and suppressor used. Regardless, all suppressed firearms will get dirtier faster and require more frequent cleaning. Increased chamber fouling may cause failures to extract with increasing frequency. If you experience excessive failures to extract, follow the instructions for cleaning, paying particular attention to the chamber.

WARNING: NEVER use "rimfire" suppressors rated for .22LR, .22WMR, and .17HMR unless they are specifically rated by the manufacturer to handle 5.7x28mm caliber ammunition as the suppressor may be damaged or destroyed, potentially causing injury. Keep in mind, even the most robust rimfire suppressors are not designed to handle the gas volume produced by 5.7x28mm caliber ammunition. This results in a louder pop and high backpressure that blows the products of combustion rearwards into the chamber. This will rapidly foul the chamber resulting in frequent malfunctions. Better function and suppression may be achieved using high volume pistol-rated suppressors for 5.56 NATO / .223 Remington caliber. Some .30 caliber pistol suppressors or 9mm direct thread carbine suppressors may also be used but may have diminished sound suppression. In all cases, suppressor use will lead to increased fouling and require more frequent cleaning to help prevent malfunctions.

Always check with the suppressor manufacturer first to ensure your suppressor is compatible with 5.7x28mm caliber ammunition prior to using it on the **LG CHARGER**[™].



WARNING-MUZZLE DEVICES

Ensure that all muzzle devices installed on the **LC CHARGER**[™] are intended for use on firearms chambered in the caliber marked on the barrel. Failure to do so may result in injury and damage to your pistol.



SHIPPING FIREARMS FOR REPAIR

NOTE: You must obtain a Repair Authorization Number before returning your firearm. An authorization number can be obtained by contacting Customer Service online at Ruger.com or calling the Customer Service Department at 336-949-5200. Firearms should be sent prepaid. We will not accept collect shipments. Any RUGER® LC CHARGER™ returned to the factory for repair should be sent to: Sturm, Ruger & Company, Inc., Customer Service Department, 200 Ruger Road, Prescott, AZ 86301.

The Federal Gun Control Act, as well as the laws of most states and localities, do not prohibit an individual (who is not otherwise barred from purchasing or possessing a firearm) from shipping a firearm directly to the manufacturer for repair. However, before you ship your firearm to us, be certain that your state or locality does not have a law or regulation which will prohibit you from receiving the firearm (or any included magazines) from us after repair. If such receipt is prohibited, please have a federally licensed firearms dealer ship the firearm to us. If your firearm is sent to us by a dealer, it will be returned to that dealer after being repaired. If a handgun (pistol or revolver) is shipped by an individual who does not hold a Federal Firearms License, it must be shipped for overnight delivery via U.P.S., Federal Express or other, similar private overnight service.

NOTE: Persons who do not hold a Federal Firearms License are prohibited by Federal law from shipping a handgun by U.S. Mail. Handguns mailed in violation of the law may be impounded or confiscated by the Post Office and the non-FFL may be subject to prosecution. Rifles and shotguns may be shipped via U.S. Mail.

Please do not include any cases, slings, telescopic sights, or custom accessories with a firearm being shipped to the factory for service. **DO NOT SEND FIREARM BOXES OR LITERATURE THAT YOU CONSIDER TO BE COLLECTOR'S ITEMS – THESE ARE INVARIABLY DAMAGED OR DESTROYED IN SHIPMENT.** Always insure your shipment.

Enclose a letter which includes your name, address, telephone number, firearm serial number and model, and repair authorization number. Describe in detail the trouble you have experienced with your firearm, or the work you wish to have done. Merely stating that the firearm "needs repair" is inadequate information. Please enclose copies of any previous correspondence.

All work performed is subject to a minimum labor charge and charges for shipping and handling. Most models can be reblued, but custom gunsmithing service or nonstandard alterations are NOT AVAILABLE from Ruger Customer Service Departments. Please contact the Customer Service Department for pricing information.





THE BASIC RULES OF SAFE FIREARMS HANDLING

We believe that Americans have a right to purchase and use firearms for lawful purposes. The private ownership of firearms in America is traditional, but that ownership imposes the responsibility on the gun owner to use his firearms in a way which will ensure his own safety and that of others. When firearms are used in a safe and responsible manner, they are a great source of pleasure and satisfaction, and represent a fundamental part of our personal liberty.

Firearms do not cause accidents! Firearms accidents are almost always found to have been the result of carelessness or ignorance on the part of the shooter of the basic rules of safe gun handling.

The following rules must be observed by gun users at all times. Safe gun handling is not just desirable, it is absolutely essential to your safety, the safety of others, and the continuation of gun ownership and sport shooting as we know it today.

1. LEARN THE MECHANICAL AND HANDLING CHARACTERISTICS OF THE FIREARM YOU ARE USING.

Not all firearms are the same. The method of carrying and handling firearms



varies in accordance with the mechanical provisions for avoiding accidental discharge and the various proper procedures for loading and unloading. No person should handle any firearm without first having thoroughly familiarized himself with the particular type of firearm he is using, and with safe gun handling in general.

2. ALWAYS KEEP THE MUZZLE POINTED IN A SAFE DIRECTION.



Be sure of the bullet stop behind your target, even when dry-firing. Never let the muzzle of a firearm point at any part of your body or at another person. This is particularly important when loading or unloading a firearm. In the event of an accidental discharge, no injury can occur as long as the muzzle is pointing in a safe direction. A safe direction means a direction that will not permit a discharged bullet to strike a person, or to strike an object from which the bullet may ricochet.

A safe direction must take into account the fact that a bullet may penetrate a wall, ceiling, floor, window, etc., and strike a person or damage property. Make it a habit to know exactly where the muzzle of your gun is pointing whenever you handle it, and be sure that you are always in control of the direction in which the muzzle is pointing, even if you fall or stumble. Keep your finger off the trigger until you are ready to shoot.

3. FIREARMS SHOULD BE UNLOADED WHEN NOT IN USE.



Firearms should be loaded only when you are in the field or on the target range or shooting area, ready to shoot. Firearms and ammunition should be securely locked in safes, racks or cabinets, or by using the locking device supplied with the firearm, when not in use. Ammunition should safely be stored separate from firearms. Store your firearms out of sight of visitors and children. It is the gun owner's responsibility to be certain that children and

persons unfamiliar with firearms cannot gain access to firearms, ammunition, or components.

4. BE SURE THE BARREL IS CLEAR OF OBSTRUCTIONS BEFORE SHOOTING.

Even a bit of mud, snow or excess lubricating oil or grease in the bore may cause the barrel to bulge, or even burst on firing, and can cause serious injury to the shooter and bystanders. Be sure that you are using ammunition of the proper caliber and loading for the gun you are using. If the report or recoil on firing seems weak, or doesn't seem quite right, CEASE FIRING IMMEDIATELY, unload your firearm, and check to be sure that no obstruction has



become lodged in the barrel. Never try to shoot out an obstruction!



5. BE SURE OF YOUR TARGET BEFORE YOU SHOOT.

Don't shoot unless you know exactly where your bullet is going to strike. Be sure of the bullet stop behind your target, even when dry-firing with an unloaded gun. If you are in the field hunting, do not fire at a movement or noise. Take the time to be absolutely certain of your target before you pull the trigger.

6. WEAR SHOOTING GLASSES AND HEARING PROTECTION WHEN YOU SHOOT.

All shooters should wear protective shooting glasses and adequate hearing protection when shooting. Exposure to shooting noise can damage hearing, and wearing adequate eye protection when shooting is essential.



7. NEVER CLIMB A TREE OR FENCE WITH A LOADED FIREARM.

Put the firearm down carefully before climbing a fence, and unload it before climbing or descending a tree or jumping over a ditch or other obstruction. Never pull or push a loaded firearm toward yourself or another person. When in doubt, or whenever you are about to do anything awkward, unload your gun!

8. DON'T SHOOT AT A HARD SURFACE OR AT WATER.

Bullets can glance off many surfaces like rocks or the surface of water and travel in unpredictable directions with considerable velocity.

9. NEVER TRANSPORT A LOADED FIREARM.

Firearms should always be unloaded before being placed in a vehicle. A suitable carrying case or scabbard should be used to carry an unloaded firearm to and from the shooting area.

10. AVOID ALCOHOLIC BEVERAGES WHEN SHOOTING.

Don't drink until the day's shooting is over. Handling firearms while under the influence of alcohol in any form, or medications that could affect your judgment or coordination, constitutes a criminal disregard for the safety of others.
